Precision Agriculture is Annual Meeting Focus

“Precision Agriculture: Information and Technologies for Soil and Crop Management” is the emphasis of the technical portion of the joint Annual Meetings of the North Dakota and South Dakota Chapters of the Soil and Water Conservation Society and the Professional Soil Classifiers Association of North Dakota, which will be held Thursday, October 11, at the Kelly Inn in Bismarck, North Dakota, and Friday, October 12, at the USDA Plant Materials Center and the Soil Quality Demonstration Farm at Menoken, North Dakota. SWCS business meetings will be from 4:45 to 5:45 p.m. October 11; the PSCAND business meeting will be from 6:30 to 7:45 a.m. October 12. An awards banquet will be held at 7 p.m. October 11 followed by the conclusion of the silent auction, which raises funds for the chapters’ scholarship and educational activities.

Speakers from the USDA’s Agricultural Research Service and Natural Resources Conservation Service and the North Dakota and South Dakota Extension Service will offer information on precision agriculture research and application; technology for precision agriculture and how to use it; LIDAR and 3-D mapping; remotely measuring crop residue and a tool to account for this input; as well as soils, nutrients, and agronomic interpretations related to precision agriculture. Registration begins at 7:30 a.m.; speakers start at 8:45 a.m. and end by 4:30 p.m. on October 11. USDA Plant Materials Center employees will discuss the National Cover Crop Study at 8 a.m. October 12. Soil scientists will examine the physical, chemical, and biological properties of soil using a soil pit and simple soil field assessment tools. The group will then travel to the Soil Quality Demonstration Farm at Menoken, North Dakota, to see a demonstration and discuss cover crops, compost, compost tea, and soil dynamic properties. There will also be a hands-on hydric soil indicators training primer at the site.

Member registration is \$40, non-member \$50, through October 1. After that date, registration is \$50 for members and \$60 for non-members.
